This template can be used for multiple purposes:

 It enables schools to effectively plan their use of the Primary PE and sport premium

 It helps schools to meet the requirements (as set out in guidance) to publish information on their Primary PE and sport premium

 It will be an effective document to support Ofsted inspections enabling schools to evidence progress in Physical Education (PE) and evidence swimming attainment, which forms part of the PE National Curriculum. We would recommend schools consider the Intent, Implementation and Impact of any spend, as examined within the Education Inspection Framework.

It is important that your grant is used effectively and based on school need.

Schools must use the funding to make additional and sustainable improvements to the quality of the PE, School Sport and Physical Activity (PESSPA) they offer. This means that you should use

they offer. This means that you should use the Primary PE and sport premium to:

- Build capacity and capability within the school to ensure that improvements made now will benefit pupils joining the school in future years
- Develop or add to the PESSPA activities that your school already offers.

The Primary PE and sport premium should not be used to fund capital spend projects; the school's core budget should fund these. Further detail on capital expenditure can be found in the updated Primary PE and sport premium guidance.

Auditing and investing in equipment and initiatives to increase pupil participation in sport has had a significant impact on children's attitudes and involvement in sport. We continue to maintain an increasing level of participation in activities and are always considering ways to widen the variety available. Examples of this have included celebrating national dance day, 'freestyle Fridays', girls football playtimes and skipping sessions.

As a school, we continue to utilize Year 6 sports captains/leaders at every given opportunity. This has been an excellent time investment this year, as our sports leaders Sports at playtimes continue to develop and have been greatly welcomed by children in all classes. For the next academic year, playground leaders are an area to focus on to encourage participation in a variety of games all year round.
